I agree to:

- Waive all claims against Friends for Life Rescue for injury or property damage related to the adopted pet.
- Provide food, water, shelter, exercise, socialisation and veterinary treatment for my adopted pet for its entire life.
- I have sought permission from my real estate/land lord to allow a cat or kitten to reside in the premises (if applicable).
- The Cat or Kitten I have adopted will be strictly indoors unless using a safe and secure cat enclosure or secure and safe harness with lead attached at all time when outdoors.
- If my circumstances change and I can no longer care for my adopted pet, I agree not to surrender the animal to a pound/shelter but instead will seek the advice from Friends for Life Rescue and work with them to privately rehome said pet for a period of 6 months following my adoption.
- Understand Friends for Life Rescue do not offer a refund on the adoption fee after two weeks from the date of the adoption.
- Agree to respect and follow all local animal control laws.
